Mr. Abrams is the managing member of Abrams Capital and the LLC.

Each Reporting Person disclaims beneficial ownership of the reported shares except to the extent of its or his pecuniary interest therein, and the inclusion of such securities in this report shall not be deemed an admission of beneficial ownership for purposes of Section 16 or for any other purpose.

As of July 28, 2023, Abrams Capital may have been deemed to beneficially own 2,025,144 of the shares reported herein, the LP and the LLC may have been deemed to beneficially own 2,108,540 of the shares reported herein, and Mr. Abrams may have been deemed to beneficially own all of the shares reported herein.
